

Universal Design, coined by architect Ronald L. Mace, is the practice of designing the environment and its components to be accessible by all people regardless of age, size, ability, or disability. Successful Universal Design projects go beyond the requirements of the Americans with Disabilities Act (ADA) and seamlessly integrate accessible design elements, so they do not seem like an after-thought. Retrofitting a Universal Design approach to an existing project is expensive. It is important to have accessibility at the forefront of the design process from the beginning.

Accommodating all ages and abilities means considering the physical, social, and sensory needs of people to create an engaging space for all. Physical needs may include mobility concerns of the elderly, children, wheelchair users and others who require physical accommodation to access park facilities. Social needs include amenities that make the park feel safe and inviting for all visitors, including caregivers, individuals with health concerns, and people with diverse language and literacy needs. Sensory needs address accommodations for visitors who may require high or low sensory environments, including but not limited to people who are deaf, hard of hearing, blind, or have limited vision or autism spectrum disorder. Best practices were developed in coordination with the All Ages and Abilities roundtable discussion.

OVERALL DESIGN

- Wherever possible, design so that all users can have as similar and equitable an experience as possible. Integrate accessible elements into park design so that visitors with and without accessibility needs can use the same facilities, not separate ones.
- Prioritize design that gives users flexible access to nature. Provide choice in how users choose to immerse themselves in the environment.
- Provide guiet areas that are close to activity zones but provide a break from overstimulation. Quiet areas should be able to see out and be seen (prospect and refuge) and include comfortable seating and rocking benches for soothing movement.
- Include both high and low stimulation spaces for people to experience nature.
- Provide information on park accessibility online and outside of the park so that advocates and caregivers know what to expect before visiting.

CIRCULATION

- Provide wheelchair accessible paths and entryways that allow circulation to all features of parks. Pavement is best for accessible paths.
- Prioritize short distances for accessible routes between major park features (Examples: parking to playground, splash-pad to bathroom, etc.). Integrate drop-off zones where distance to parking cannot be further reduced.

SAFETY

- Provide fencing around spaces that require higher security (Example: water, playgrounds).
- Minimize or eliminate vehicular road crossings to access park amenities.
- Where vehicular road crossings are essential, provide multiple levels of accessibility: Physical - Curb cuts; Visual - detectable warning strips, lights; Audible - crossing signal sounds.
- Minimize materials that may be a safety concern. Gravel or pebbles for example may be a choking hazard. Some plant materials may be dangerous if ingested or touched.
- Provide warnings of safety hazards.

AMENITIES & ENHANCEMENTS

- Include wheelchair accessible bathrooms and changing stations for children and adults nearby park destinations.
- Provide inclusive signage and wayfinding devices that accommodate different languages, abilities, and levels of literacy (Examples: ASL inclusive, braille, auditory signals, color coding or visual cues). Present essential information in redundant ways. One method of communication will not work for all
- Include park equipment of varying heights, opening sizes, indoor and outdoor sensory boards.
- Locate sensory garden away from higher activity areas.
- Provide elevated garden bed options for users

- with difficulty bending over.
- Include rentable all-terrain vehicles and wheelchairs for in-park use.
- Include water fountains and water bottle refilling stations.
- In all facilities, provide space for the use of assistive devices such as wheelchairs, walkers.

Discussion:

The meeting began with introductions of the design team and county staff, followed by a presentation by Floura Teeter discussing the park planning process, an outline for public engagement, and overview of context for each park site.

Action Items in italics. Refer to the Action Item / Decision Log.

NO.	DISCUSSION					
1	CCRPT views both parks as Regional Park opportunities that draw from outside the county, including DC and Virginia residents. The new parks should be viewed as destinations with unique amenities that give visitors a reason to stay overnight in Charles County with visits to multiple destinations throughout the County.					
2	Explore opportunities for camping or cabins within either park. It was noted there is high demand for primitive camping and cabins throughout the state – with reservations booked a year in advance. Coordinate with DNR for management of camping reservations.					
3	Explore ways to provide unique programming: Concerts Movie Nights Farmers Markets Hayrides Educational Programming / Public School Outings Parties / Weddings Accommodations for overnight equestrian stays					
4	During Task 3 at approximately December 2022, Design team and County staff to work together to gather approximate Operations and Maintenance budgets for both parks to apply for funding.					
5	Popes Creek Park: O Large field at Popes Creek property has a Farm Easement.					

- There is tree mitigation planting required for the Popes Creek Rail Trail project and is designated for planting at Popes Creek Park, specifically around the steep sloped areas. County to provide information to design team to coordinate the master plan.
- Popes Creek programming should relate to water sports (kayaking, canoeing, boating, beach access). Design team to research management options implemented in other areas of the state.
- Existing pier to remain at Gilligan's property. Design team to identify the needs to repair/rebuild.
- Accommodate stage near existing building boats will dock in the Potomac during events.
- Desire for existing parking lot to remain at Gilligan's property because of Critical Area requirements and regulations.
- Design should expand the site and look at connections to surrounding projects including the rail trail and restaurants. Emphasis on building a park system.
- 6 La Plata Farm Park:
 - Consider including historical components, old tobacco barns, community gardens. Design team preparing cultural and historical analysis for each park site.
 - There are 52 wooden horses being stored by the county for a future Carousel.
 There might already be a project to locate them in Indian Head, but could possibly create a spot in the La Plata Farm property for a future carousel pavilion as a county attraction. Only the horses are built, not the actual carousel.
 - The County doesn't have an immediate need for additional sports / recreation fields.
 - The desired programming for La Plata is all things farming and nature play that currently doesn't exist in the Charles County Parks system.
 - Design should expand the site and look at connections to surrounding projects including Wills Memorial Park. Emphasis on building a park system.
- Steering Committees will be convened for each park. Design team to provide recommendations for interest groups. Potential members to be identified and committees convened by the County in the coming month with the first steering committee meeting to be held between Labor Day and mid-September.

VOLUNTEER PARK PLANNING TASK FORCE MEETING #1 - SEPTEMBER 19, 2022 WALDORF SENIOR CENTER

Kelli Beavers, Director, and Sam Drury, Deputy Director, Departments of Recreation, Parks, and Tourism (RPT) welcomed the 30+ attendees. RPT is starting a new process for planning and developing new parks and recreation facilities across the County. Each new park/recreation facility will go through an intentional process of developing concepts that meet local and countywide needs and engaging residents from across the county. This approach builds from the community input and technical assessment conducted during the Land Preservation, Recreation, and Parks planning process in 2021-2022.

Megan Maffeo of Floura Teeter Landscape Architects (FTLA) described a typical park planning process that includes establishing a vision, theme, and guiding principles for the park, based on both community and countywide values, needs and priorities; concepts are developed and shared with the Task Force and refined, then shared with the local community for further feedback; a master plan for the park is developed that can be built with flexibility over time.

Megan and Zolna Russell of FTLA then provided a preliminary overview of the sites at La Plata Farm and Pope's Creek and Richard Polk of Vista Design provided the same for Waldorf Park. Preliminary design themes:

La Plata Farm Park – Agricultural Heritage, Community Front Porch, Discovery (Demonstration & Learn-to Events.

Pope's Creek – Tidal & Ecosystems Education; Adventure in Nature; Celebration Park; Aquatic Recreation

Waldorf Park - Active Recreation, Family Friendly, Environmental Preservation.

After the overview of preliminary themes, task force members held a brainstorm session to discuss their priorities for recreation and programming at each proposed park. A catalogue of responses is attached.

To close the meeting, Megan thanked everyone for attending, encouraged participants to share the project ideas with neighbors and friends, and to attend the next task force meeting on November 14th at Waldorf Senior Center.

DISCUSSION

A recap of task force member ideas collected at the first task force meeting was presented; the ideas were cataloged by use category – active recreation, passive recreation, or programming.

Assessment of task member ideas revealed the following common threads:

- Popes Creek: Waterfront should be the gem of the park; Primary focus active water based recreation; Secondary focus – nature based play and programming.
- Waldorf Park: Hub for organized sports and supporting uses; Family oriented including recreation options for visitors not participating in sports; Passive recreation that complement natural resources.
- La Plata Farm Park: A balance of active and passive recreation; Emphasis on programmed activities; Integrate options for revenue generating activities; Social connections with gardening and farm based organizations; physical connections to Wills Memorial Park.

A set of guiding principles were established for each park building upon the design themes and common threads. The guiding principles are a framework that guides decision making for the concept plans to check that design decisions reflect the park vision and are ultimately responsive to community preferences.

- Popes Creek:
 - 1. Maximize the waterfront for aquatic recreation activities and views.
 - 2. Consider park features as a living classroom for ecosystem education and nature immersion.
 - 3. Plan for programs and events that define this park as a destination and
 - 4. Connect to, rather than duplicate, surrounding attractions.
- 5. Preserve and enhance natural ecosystems; plan for resiliency and a park that can adapt to potential impacts caused by a changing climate.
- Waldorf Park

- 1. Establish the park as a destination for the entire family.
- 2. Maximize interconnectivity between various park elements.
- Offer a wide range of amenities that appeal to all family members and encourage cross-use of amenities by patrons.
- 4. Distribute playground amenities throughout the park.
- Preserve and enhance natural areas while presenting opportunities for environmental education as well as physical activities in a natural setting.
- La Plata Farm Park
 - Plan for programming and events to promote discovery of the agricultural heritage of Charles County and significance to everyday life.
 - 2. Promote community connections, both physical and social.
 - Integrate a variety of active and passive uses for year-round use and seasonal events.
 - 4. Provide multi-functional park features as opportunities for revenue generation.

An overview of the concept plans, circulation diagrams, and precedent images were presented to the task force members followed by a breakout session. During the breakout session, task force members circulated through stations for each park where more in depth discussion and ideas were had.

Task Force members evaluated each of the parks and provided input on the most attractive park feature, features that they want to explore further, features that are NOT a good fit, and features that are missing or would enhance the experience and functionality of the park. Input and activity responses have been cataloged and are included as an attachment to these minutes.

Concerns / Missing Features

- Secure kayak dropoff/temp. storage is needed at Popes Creek Park.
- Ensure access to bathrooms, drinking water and water bottle fill stations.
- Access from St. Marys Ave into La Plata Farm Park minimize impacts to residential neighbors, buffering between parking areas and St. Marys Ave is desired.
- Parking accommodations; review quantity of parking needed, distribution, need and realities for a shuttle between upland and Gilligan's pier at Popes Creek, explore shared parking with Captain Billy's restaurant.
- Refreshments and snacks for kids, affordable food options specifically mentioned for Popes Creek.

Next steps

Refine concept to a draft master plan – decision making that weighs task force and CCRPT input.

The community was polled for input on scheduling a public open house in February 2023. Two public open house meetings will be held to facilitate public awareness and solicit input, these meetings will be open for County residents to attend. Meeting will be scheduled either Wed/Thurs, or Thurs/Sat. dates.

Identify participants and schedule meetings for target discussions for specific park elements or partnerships.

Refine programming and special event opportunities for each park.

Identify revenue generators and options for vendor or concessionaire operations and management (demonstration gardens & greenhouse, classes/how to events, kayak rentals, commercial kitchen).

Discussion for budget, operations, and phasing of the masterplan for each park as well as prioritizing implementation among the 3 parks.

	Floura Teeter provided a brief overview of the current park master planning projects and public engagement process for the Popes Creek Waterfront Park and the La Plata Farm Park. We explained our engagement with the volunteer task force members and that inclusive design for residents of all ages and abilities has been a topic raised at each meeting. This focus group meeting was convened as a one time discussion to better understand from residents with first hand experience either through their own disabilities or interactions with disabled persons.
1	It was explained that our intentions are to better understand the challenges and needs of disabled persons. Using this information we will establish a set of best practices to integrate into the design of the parks.

	Barriers
	 Accessible bathrooms with changes stations for adults Not all sections of the park have accessible routes






