#### **Birthday Party Policies and Procedures**

- 1. Reservations are on a first-come, first-served basis.
- 2. Reservations must be made at least two weeks in advance and will be accepted three months in advance.
- Reservations must be made in person at desired party location and must include a signed Birthday Party Registration Form with a non-refundable 50% deposit. The remaining balance is due before the start of the party.
- Reservations are not accepted by telephone, mail, facsimile or email. Check, money orders, and Visa or Master Card are accepted forms of payment at all locations. Cash is accepted everywhere except at school-based Community Centers.
- 5. As the party sponsor, you are responsible for the behavior and actions of your guests. Should unruly behavior occur, staff has the authority to prohibit anyone from the party area, and/or end the party early.
- 6. All party packages are scheduled for two hours. The first hour will include selected party activities and the second hour will include a birthday celebration in our party area.
- 7. Set up may begin 15 minutes prior to the start of your party. All guests must exit the party area by the end of your scheduled
- 8. All parties include the following items: set up and clean up, (20) 8 oz bottles of water, one party favor for each child, and paper products (if requested).
- 9. Other items such as: Birthday cakes, drinks, and food will not be provided by Charles County Department of Recreation, Parks, and Tourism. These items will be permitted at the party sponsors own expense. Refrigerators and freezers are not available, please plan accordingly.
- 10. The birthday child must be between the ages of 4-12. Guests 6 and younger must be accompanied by a supervising adult.
- 11. The birthday child is included in the count of 1-20. There is a \$10 fee for each additional participant past what was originally booked. Max 30 participants; varies by location.
- 12. All party participants must have a wavier form signed and present at the start of the party in order to participate. Waiver form must be signed by child's parent or guardian.
- 13. Food may be consumed in designated areas only. No food, drinks, or glass containers are permitted on the pool deck.
- 14. Music is allowed in designated eating areas only. Volume levels must be kept to a minimum and music may not have profanities or be offensive.
- 15. No alcoholic beverages and no smoking (including e-cigarettes). As a state law, this includes the center area, parking area and other surrounding areas while on school grounds.
- 16. Use of the facility after the scheduled party is not permitted.
- 17. Use of the pool after the scheduled party is permitted during our open swim hours with paid daily admission. Children 12 and younger must be accompanied by a supervising adult.
- 18. Those not on the birthday guest list, including parents must pay the daily admission if using pool (\$6 for adults 13-59; \$5 for children 3-12 and adults 60+; children 2 and younger are free).

#### **Refund Policy**

50% deposit is non-refundable. Once the party has started, if there is a closure due to weather, power outage, or circumstances beyond our control, you will receive a partial refund if the remaining time is canceled. Refunds over the 50% deposit may be approved with written notification if received seven working days prior to scheduled start of program. A \$10.00 administrative fee will be deducted from the total refund, regardless of circumstances, unless the party is canceled by Charles County RP&T. In lieu of refund, the party can be rescheduled. Please call your party location with concerns to forecasted inclement weather in regard to your reservation.
